Introduction MA Program

In 1998 the UDYANA UNIVERSITY started to compose the first international exchange program in the Republic of Indonesia. The focus was students from the faculties of economics and business management. The name of study program is IBS – International Business Studies, which includes business management and business administration. It was composed in cooperation with the *AfM* – *Arbeitsgemeinschaft für Marketingprofessoren (German Association of Marketing Professors)*. The chairmen of the team: Prof. Dr. Egon Heil / FH Rosenheim and Prof. Dr. Stephan Passon / University of Applied Sciences Dortmund, FED. REPUBLIC OF GERMANY.

This study program on Bachelor's level is very well established since 1999 and become worldwide known for its quality and efficiency. The Udayana University received from the Minister of Education the national award "High Excellency" for this study program.

In 2013 the Institute of International Business Studies started to compose a study program on **Master** level. Today 7 subjects are in the curriculum for the MA student's choice.

Student has to select minimum 2 out of 7 the subjects see below and has to complete 16 ECTS. The attendance is minimum 75 percent (signature). The Master subjects as follows:

- (MA.01) Business Economics in Emerging Countries 8 ECTS
- (MA.02) Global Management Projects 8 ECTS
- (MA.03) Multinational Service Marketing (in 2020/21 Tourism Marketing) 6 ECTS
- (MA.04) Multinational Entrepreneurship 6 ECTS
- (MA.05) Intercultural Management 4 ECTS
- (MA.06) Intercultural Leadership 6 ECTS
- (MA.07) Multinational Locgistic and SCM 6 ECTS
