### 1. Types of personal data to be processed

RMIT collects student's personal, sensitive and health information as necessary for its core functions.

- i. Personal information: information or data about an identifiable or easily identifiable individual;
- ii. Sensitive information: information or data associated with individual privacy, with the infringement of which directly affects an individual's legal rights and interests, such as race, ethnicity, political opinions, beliefs, sexual orientation, criminal history, memberships, genetic and biometric data; and
- iii. Health information: information about an individual's physical, mental or psychological health.

### 2. Purposes of personal data processing

RMIT collects students' personal information to manage enrolment and candidature in line with its policies and procedures. This information is also used to offer relevant opportunities, support services, alumni engagement, and extracurricular activities. If students do not provide the requested information, RMIT may be unable to deliver essential educational services or grant access to its systems.

### 3. Entities involved in the personal data processing

RMIT may store students' personal information in externally hosted applications, some of which are located outside Vietnam or Australia. These third-party service providers, including Google, Microsoft, Adobe, Canvas, and others, are required to uphold the same privacy standards as RMIT. Although students' data—such as Student ID, name, email, and assessment results—may be disclosed to these providers, RMIT retains full control over its management and use. In addition, RMIT may be required to disclose information in certain circumstances, for example to the government agencies, including the Ministry of Education and Training.

### 4. Rights and obligations of students as data subjects

Students are obligated to provide RMIT with accurate and current information in the first instance, and to notify RMIT when their circumstances or details change. Students have the right to access their personal information held by RMIT, including in portable form, and to request its correction, update, amendment, or deletion. Students may also withdraw their consent or ask RMIT to restrict how their data is used. In some cases, students can manage their information directly through online portals like myRMIT, or by contacting relevant RMIT departments. If access is not appropriate, students may need to submit a formal Freedom of Information request under applicable law.

Additionally, students have rights to rectification, erasure, objection, data portability, and to file a complaint if their concerns are not resolved.

RMIT Privacy Statement may be amended from time to time; hence students should access this Privacy Statement periodically to stay informed of any updates or changes.
